Five professional development days were built into the work year calendar for years 2016-2017 and 2017-2018. Four professional development days have been built into the work year calendar for 2018-2019 and 2019-2020, with one PD designated as a site specific PD opportunity. District staff were surveyed to collect teacher professional development interest/need. The area of highest interest/need were selected as topics for our professional development days. The professional development days were divided into elementary and secondary topics, and the PD was delivered in a workshop model with a variety of sessions offered. Some of the workshop sessions offered included, math implementation, site-level collaboration, technology support, ACES/Trauma Informed Classroom Management, effective influences on student learning, accessing/discerning reliable information, and environmental literacy. The K-12 Curriculum/Staff Development committee met and planned the current three professional development days. All teachers participated as members of Professional Learning Networks (PLNs) and met monthly to further their collaborative work. Teachers also are provided time on early-release Wednesdays district wide for teachers to participate in collaboration, professional development, and staff meetings.
