The 6th Grade Academy at Petaluma Junior High School Safety Plan is incorporated in the Petaluma Junior High School plan and is annually reviewed and practiced each year as part of an on going effort to update our procedures and introduce new staff to the protocol. In collaboration with a district level safety grant, fire, earthquake, and lockdown drills involving the entire staff and student body are conducted monthly. The Principal Advisory Committee reviews the plan with input from the two 6th Grade Academy teachers and provides opportunities for parent review and input. District and local emergency agencies are invited to attend each drill, monitor, and provide feedback on the effectiveness of the drills. The principal also meets with law enforcement to review needs for the campus.

Sixth Grade Academy is no longer an active school as of June 30, 2020.

Four (4) professional development days are built into the school calendar. District staff were surveyed to collect teacher professional development interest/need. The area of highest interest/need were selected as topics for the professional development days. Professional development days were divided into elementary and secondary topics, and the PD was delivered in a workshop model with a variety of sessions offered. Some of the workshop sessions offered included, math implementation, site-level collaboration, technology support, Maker/3-D printing, inquiry and project-based learning, effective influences on student learning, classroom management, accessing/discerning reliable information, and environmental literacy. Teachers also attended workshops, trainings, and conferences provided by the Sonoma County Office of Education, among other outside providers. To support implementation, several committees have been formed and meet regularly to plan for continued teacher support. The K-12 Curriculum/Staff Development committee met and planned the professional development days. All teachers participated as members of Professional Learning Networks (PLNs) and met monthly to further their collaborative work. Teachers also are provided time on early-release Wednesdays district wide for teachers to participate in collaboration, professional development, and staff meetings.
